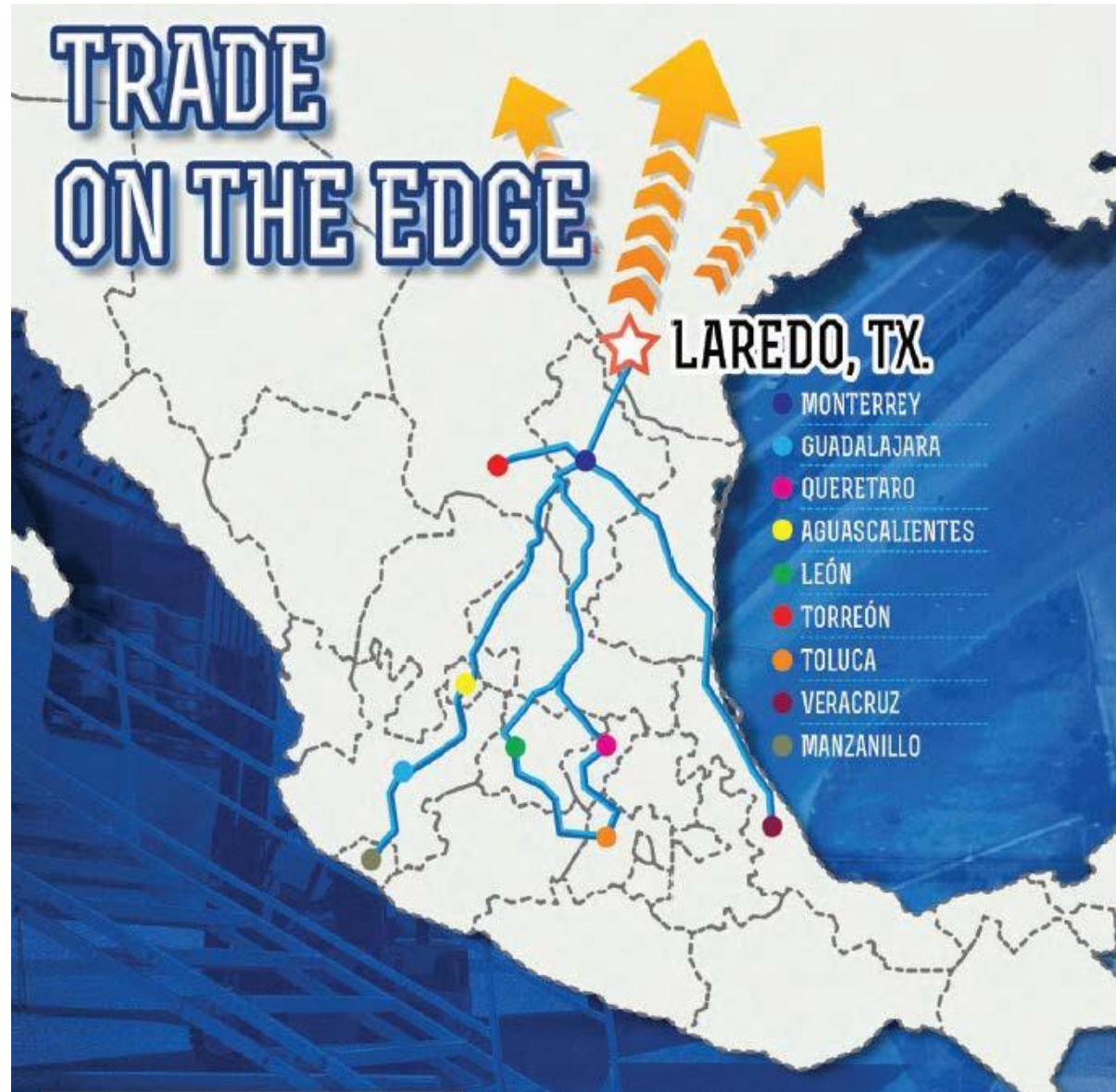

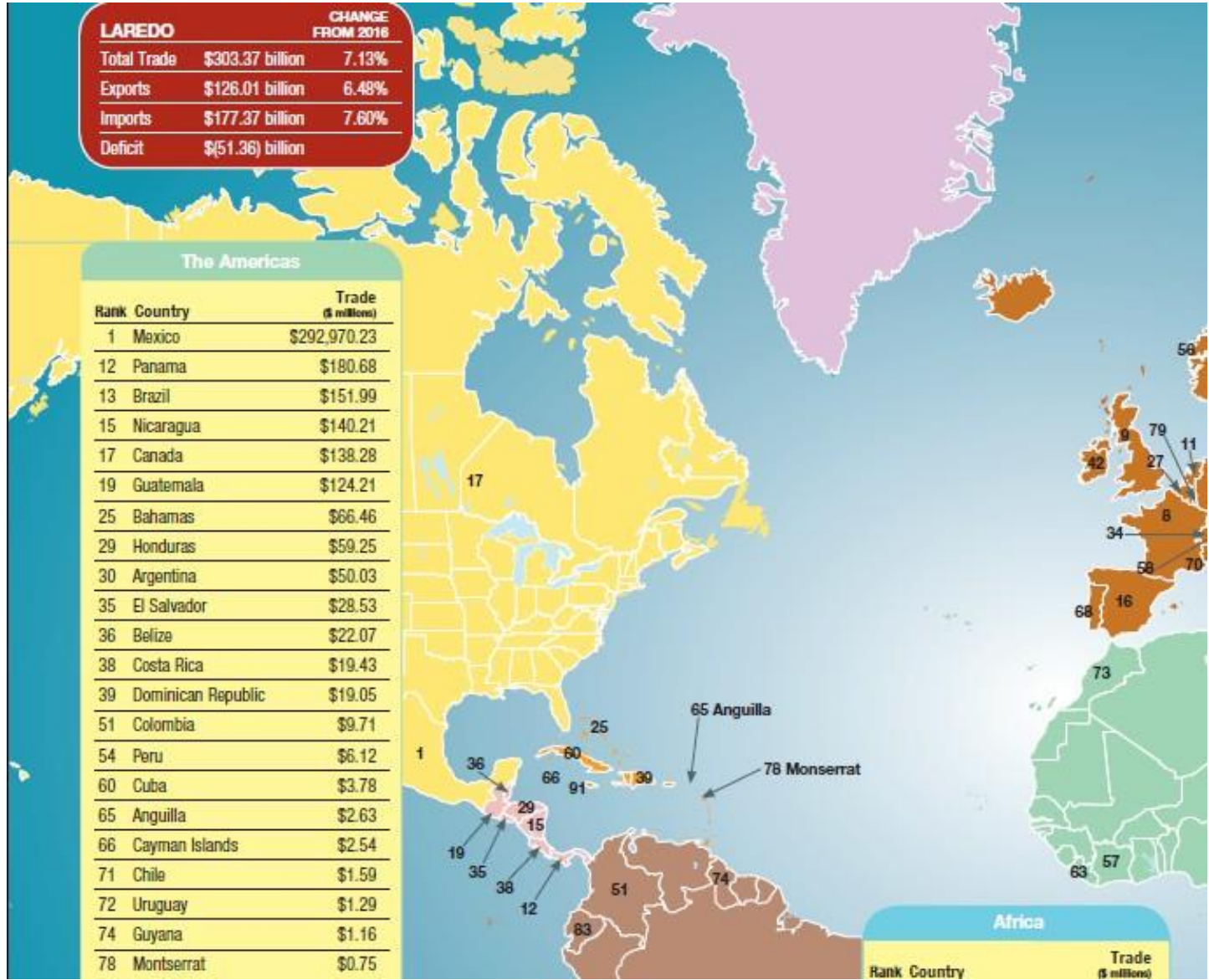

Total trade with Laredo | \$292.97 billion



Mexico trade at record, nears \$300 billion

Mexico's trade with Laredo increased 7.51 percent in 2017, from \$272.51 billion to a record-setting \$292.97 billion. The total is more than twice that of any U.S. airport, seaport or border crossing with one nation ever.

EXPORTS: The leading export, motor vehicle parts, increased 3.16 percent, to \$12.99 billion. The fastest growing top 10 export was gasoline and other fuels, which increased 43.13 percent.

IMPORTS: The fastest-growing import among the top 10 was No. 3-ranked motor vehicles, up \$5.37 billion to \$14.79 billion. The top import, motor vehicle parts, increased 2.58 percent in 2017.

BALANCE OF TRADE: Laredo ran a \$42.29 billion deficit with Mexico in 2017. For every dollar of trade between the two, 42.80 cents was a Laredo export.

MARKET SHARE: Laredo accounted for 52.59 percent of all U.S. trade with Mexico in 2017. **WC**

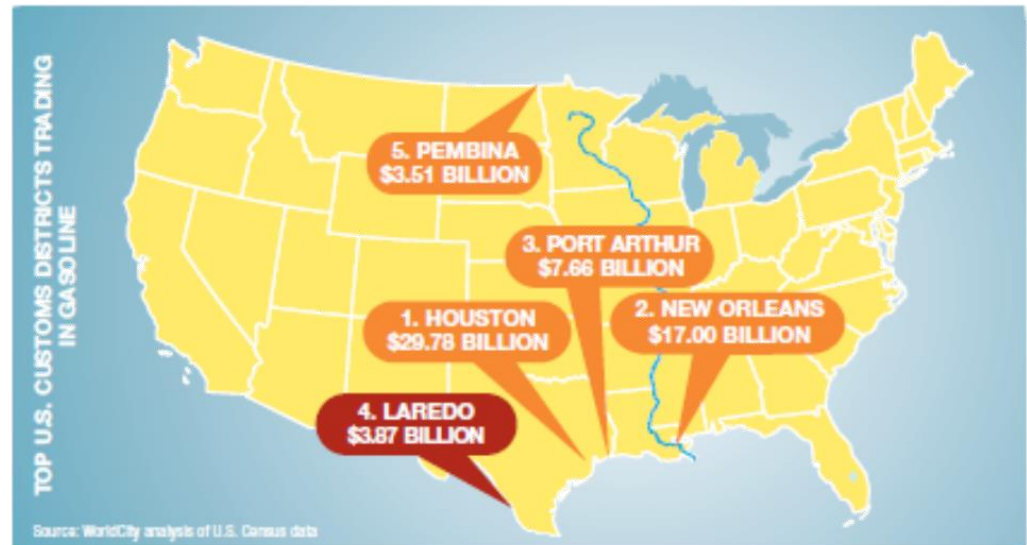

Gasoline exports surge 44%, top record from 2014

Laredo exports of gasoline and other similar fuels increased 44.46 percent in 2017 to \$3.87 billion, topping the 2014 record. The value five years ago was \$2.66 billion, when prices were weaker. While these exports from Laredo have increased 45.44 percent over the last five years, U.S. exports have decreased 24.06 percent in that time.

COUNTRIES: Almost 98 percent of all exports from Laredo in 2017 were bound for Mexico.

CUSTOMS DISTRICTS: Laredo ranked No. 4 nationally for exports of gasoline and other fuels in 2017, accounting for 4.98 percent of all U.S. exports. Houston and New Orleans continue to be the dominant export markets, accounting for about 60 percent of the total in 2017, as they have for the last five years. **WC**

Total world trade | \$2.02 billion

LGN, other gas exports top \$2 billion in 2017

Laredo exports of liquid natural gas – LNG – and other petroleum-based gases increased 28.14 percent in 2017 to \$2.02 billion. The total eclipsed the 2014 record and marked the first total to top \$2 billion. The value of these exports from Laredo five years ago was \$959.77 million, an increase of 110.31 percent over the last five years. Nationwide, exports have increased even more rapidly, up 153.02 percent in that time.

COUNTRIES: Mexico accounted for 100 percent of all Laredo exports in 2017.

CUSTOMS DISTRICTS: Laredo ranked No. 4 for exports in this category in 2017, accounting for 9.07 percent of U.S. exports. Three of the top four Customs districts for petroleum gas exports are in Texas, led by the Houston Customs district. **WC**

La mayoría de las importaciones de cerveza ahora entran por Laredo

Laredo imports of beer increased 13.6 percent in 2017 to \$2.70 billion. It marked the seventh consecutive year that beer imports through Laredo have set a record. Just in the last five years, beer imports through the Laredo Customs district, most of which cross the border at Eagle Pass, have increased 107.96 percent, almost triple the U.S. average of 37.33 percent.

COUNTRIES: More than 99 percent of all imports come from Mexico.

CUSTOMS DISTRICTS: Laredo ranked No. 1 for beer imports in 2017, accounting for 53.08 percent of U.S. imports to the world. It marked the first time that Laredo accounted for a majority of U.S. beer imports. Imports grew the most from Nogales/Phoenix, which saw its inbound shipments increase 50.90 percent, equal to \$97.95 million, over the total from the previous year. *WC*
